- **Terminology:** Changed "approved" to "verified" in the delegate portal without objection.

- **Notifications:** Agreed without objection to email verification notices to delegates (where emails are available) and to notify state or delegation chairs.
- **Deadlines:** Observed that no official deadline can be set prior to the bylaws, but the committee should reach out to the states to ensure they don't wait until the last minute.
- **State Follow-up:** Consensus that committee members should follow up with states that have not yet entered their delegates.
- **Bylaw Silence:** Noted that if state bylaws are silent on national membership, the state entering a name into the portal affirms the individual meets state requirements.
